ELECTION OF UNITE EXECUTIVE COUNCIL 2011 – 2014

The ballot is being called in accordance with Rule 16 and will commence with an invitation to branches and workplaces to submit nominations. The timetable for nominations will be:

Last date for Receipt of nominations	14th February 2011
Last date for Acceptance and Receipt of Election Address	21st February 2011
Voting Period	25th March – 15th April 2011
Count	16-17 April 2011

If your workplace wishes to make a nomination you should ensure that your meeting is held within the nomination period 10th January to 7th February 2011.

In accordance with Rule 16(4) the Executive Council has appointed the Joint General Secretary, Tony Woodley as Returning Officer (address on this letterhead).
