2.2 Election of Standing Orders Committee 2015

Adrian Weir advised that it was necessary for the Council to determine the procedure for the election of the Standing Orders Committee, at the forthcoming Rules Conference, for the 2015 Rules Conference. Ten people should be elected with a requirement for gender and ethnic proportionality of one BAEM member and a minimum of three women.

It is proposed that the election will be conducted as for the Policy Conference, on a Regional basis. If proportionality is not achieved, a second round of balloting, from existing women and/or BAEM candidates, will be held on a conference wide basis. Only if there is an insufficient number of appropriate candidates for the second round of balloting will a second round of nominations be called for. Should the additional member system be used, no Region may have more than two members of the SOC after the second round of balloting.
